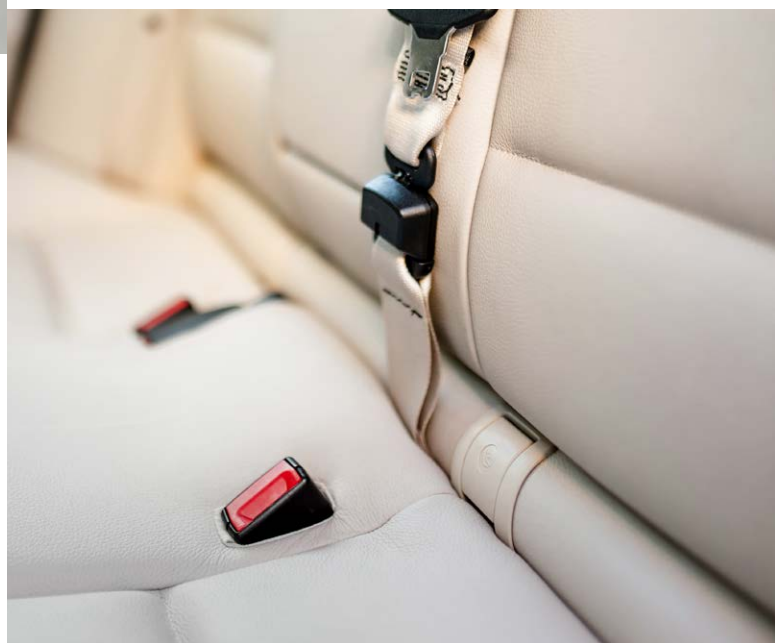

- Convertible and vinyl tops, including trim and moldings
- Audio equipment, speakers and systems
- Hood ornaments and body insignia

## Coverage exclusions may apply<sup>2</sup>:

- Any itemized excess wear and tear charge that exceeds \$500, or \$1,000, depending on the maximum single event limit you select.

- Repairs performed prior to contract termination
- Missed scheduled maintenance charges
- Charges for alterations or modifications to vehicle
- If vehicle is used for competitive driving, racing or a prohibited commercial purpose
- Any charges caused by customer's wrongful or intentional acts

## Terms of Program

- Up to \$5,000 benefit
- Maximum 72-month term
- \$150,000 max MSRP
- Claims processed within 10 days of receipt of paperwork
- Cancelable within 60 days for full refund
- Available at time of vehicle lease only
- **Open Term Coverage** allows the vehicle turn-in at any time prior to or within 1 year after the original scheduled termination date
- **Standard Coverage** allows the vehicle turn-in up to 90 days prior to or 90 days after the original scheduled termination date
- Available on **certified pre-owned vehicles**

## Exclusions of Program

- Any itemized wear and tear charge that exceeds the selected single event limit (\$500 or \$1,000)
- Repairs completed prior to contract termination
- Alteration charges
